The Clerk of the Board is defined in California State law as a County Officer and can be either the County Clerk (acting in an ex-officio capacity) or a separately appointed individual in those counties which have passed an ordinance, pursuant to Government Code Section 25100.5, establishing the Clerk of the Board as a separate position to be appointed by the Board of Supervisors in the same manner as other county officers are appointed. Regardless of how the office is held, there is only one Clerk of the Board for each county. This session focuses on the role of the Clerk of the Board and, among other topics, will cover:

- The roles of the Clerk, CAO, and County Counsel in your Board meetings;
- o The roles of the Clerk in the agenda workflow process; and
- o Building relationships with your Board of Supervisors and their staff.

Get ready to learn and hear from your colleagues as they discuss their experiences and their advice for Clerks. Time will be allotted for a Q&A session and for you to share your experience.
