SUBJECT: AB 292 (Pellerin) Primary Elections: ballots - SUPPORT if Amended

Dear Assemblymember Bryan:

The California Association of Clerks and Election Officials (CACEO) Elections Legislative Committee is pleased to support Assembly Bill 292 (Pellerin) if amended to provide voters who have declined to disclose a political party preference, with a non-partisan Presidential Primary Election ballot that contains the names of all candidates of parties that permit crossover voting.

Existing law authorizes no party preference voters to cast a crossover ballot for a party that allows no party preference voters to vote for the party's Presidential candidate nominees without changing their party preference in their registration file. Before the Presidential Primary Election, county elections officials are required to mail no party preference voters a notice and application for a crossover ballot.

AB 292 would require county elections officials to provide voters who have declined to disclose a political party preference with additional information on the application about their choice. It also would allow county elections officials to accept a completed application from the voter via text. CACEO supports these changes to the notice and application process.

The bill would also require county elections officials to provide no party preference voters that do not apply for a crossover ballot with a non-partisan ballot that contains the Presidential contest with a space for the voter to write in the name of their preferred candidate. However, processing votes for write in candidates requires county elections officials to review each ballot individually and manually enter the write-in votes into the tally system. This would add cost, time, and risk to the processing of these non-partisan ballots.

In the alternative, CACEO suggests that AB 292 is amended to read the non-partisan ballot include the Presidential contest with the names of candidates of all parties that have authorized no party preference voters to vote to nominate the party's candidate for President.

CACEO greatly appreciates Assemblymember Pellerin's desire to improve the administration of the complicated Presidential Primary Election and the services provided to no party preference voters. We respectfully request the author and committee consider CACEO's suggested amendment to the non-partisan ballot requirements.
