**COUNTY BOARD OF SUPERVISORS: VACANCY: APPOINTMENT**

Requires the Governor to fill the vacancy or authorize the board of supervisors to fill the vacancy on a county board of supervisors within 180 days, if the Governor fails to act within 180 days, authorizes the board of supervisors, within the next 90 days, to appoint an individual to fill the vacancy, call a special election to fill the vacancy, or leave the vacancy open until the next regularly scheduled general election, as provided. Provides that if the Governor and board of supervisors both fail to act, the vacancy shall remain open until the next regular election at which time a successor may be elected.

**LOCAL GOVERNMENT: CITIES**

Provides that every city with a population of less than 150 people as of January 1, 2010, would be disincorporated as of 91 days after the effective date of this act, into that city's respective county, unless a county board of supervisors determines, by majority vote within the 90-day period following enactment of these provisions, that continuing such a city within that county's boundaries would serve a public purpose if the board of supervisors determines that the city is in an isolated rural location that makes it impractical for the residents of the community to organize in another form of local governance. Requires the local agency formation commission within the county to oversee the terms and conditions of the disincorporation of the city, as specified.

**ELECTIONS: STATEWIDE BALLOT PAMPHLET**

Requires the Secretary of State to include in the ballot pamphlet a list of the five highest contributors of fifty thousand dollars (\$50,000) or more to each primarily formed committee supporting each state measure and a list of the 5 highest contributors of \$50,000 or more to each primarily formed committee opposing each state measure, as well as a statement that the list reflects on the highest contributors of fifty thousand dollars (\$50,000) or more, as of 110 days before election day. Provides that candidate or other information may be added to the ballot pamphlet. Amends the Political Reform Act of 1974 by permitting or requiring the inclusion of additional information on the ballot pamphlet, would require a majority vote.

**LOBBYISTS: ONLINE DIRECTORY**

Requires that the online directory maintained by the Secretary of State also contain information regarding lobbying interests. Requires that periodic reports filed by lobbyist employers and other persons contain the bill numbers of any legislation lobbied for or against during the reporting period. Requires the Secretary of State to display on his or her Internet Web site a list of the lobbying interests containing a specific reference to a bill number.

**PRESIDENTIAL PRIMARY: ELECTION DATE**

Requires the date of the presidential primary election be changed to the first Tuesday after the first Monday in June of presidential election years, and consolidates the presidential primary election with the statewide direct primary election.

**ELECTIONS: NEW CITIZENS**

Authorizes a new citizen to register and vote at the office of, or at another location designated by, the county elections official at any time beginning on the 14<sup>th</sup> day before an election and ending at the close of polls on the election day following the date on which that person became a citizen. Revises the definition of a new citizen to mean any person who meets all the requirements of an elector of, and who has established residency in, this state, except that he or she will become a U.S. citizen after the 15th day prior to an election.

**ELECTIONS: CITY OF BELL**

Authorizes the City of Bell to comply with the alternative procedure for certification, declaration of election results, and installation of newly elected officers. Requires the city, upon completion of a vote canvass by the Los Angeles County Registrar-Recorder/County Clerk, to certify the election results to the Los Angeles County Board of Supervisors. Requires the board to adopt a resolution and declare the election results. Requires the city to install the new officers within a certain time period.

**SPECIAL ELECTION**

Provides for a statewide special election to be held on June 7, 2011, requiring the Secretary of State to place before the voters at that election a legislative constitutional amendment, as specified, relating to local government finance. Requires certain statutory deadlines are waived in relation to the placement of that measure before the voters at the June 7, 2011, statewide special election. Provides that funds necessary to pay the claims of local agencies arising from their costs incurred to conduct the June 7, 2011, statewide special election shall be included in the Budget Act of 2011 or in another statute. Becomes effective immediately.

**POLLING PLACE DESIGNATION**

Prohibits a polling place from being designated at a single family residence where a registered sex offender resides. Requires elections officials to consult the Megan's Law sex offenders; database maintained by the Department of Justice not more than 60 days prior to designating a single-family residence as a polling place. Imposes a state-mandated local program.

**ADMINISTRATIVE PROCEDURE ACT: NOTICE OF PROPOSED ACTIONS**

Requires a state agency, when it considers it appropriate, to mail or to electronically mail a notice of proposed action to adopt, amend, or repeal a regulation to local government agencies or local government agency representatives that are likely to be affected by the proposed action. Defines "local government agency representative".

**POLLING PLACES: HIGHER EDUCATION CAMPUSES**

Requires for elections conducted by a county, the county elections official to establish at least one polling place within the county's electoral jurisdiction on a higher education campus, as defined, except a county elective official of a county that does not have a higher education campus within its jurisdiction.

**ELECTIONS: SPECIFIED LOCAL OFFICES: WRITE-IN CANDIDATE**

Revises the number of voter signatures required on a write-in petition for the office of superior court judge, to at least 0.1 percent of the registered voters qualified to vote with respect to the office, provided that the petition contains at least 100 signatures but need not contain more than 600 signatures. Requires that, a statement of the write-in candidate meets the statutory and constitutional requirements for that office as specified.

**POSTING AGENDAS**

Requires the legislative body of a local agency, at least 72 hours before a regular meeting of that body, to post the agenda and staff generated reports that relate to an agenda item for the open session of that regular meeting. Requires the legislative body to post the agenda and the writings on its internet web site or in a public location if the body has not web site.

**ELECTIONS: ALL-MAILED BALLOT ELECTIONS**

Authorizes Yolo County, until December 31, 2017, to conduct elections, other than statewide primary or general elections or special elections to fill a vacancy in a state office, the Legislature, or Congress, wholly by mail if specified conditions are satisfied. Requires ballot dropoff locations provided shall consist of a locked ballot box located in a secure public building that meets the accessibility requirements for a polling place. Requires if, the county conducts an all-mailed ballot election, to report as specified to the Legislature and to the Secretary of State. Remains effective until January 1, 2018.

**CANDIDATE'S STATEMENT: NONPARTISAN OFFICE**

Prohibits the statement of a candidate for a nonpartisan local office from containing a pledge, promise, or commitment with respect to a matter that could come before the candidate in the office to which he or she is seeking election. Requires that the statement of the candidate's personal background and qualifications be limited to objective, verifiable facts concerning the candidate's experiences, accomplishments, and credentials and not include references to the candidate's beliefs, ideas, ideology, viewpoints, or campaign platform. Requires that each voter's pamphlet contain a notice informing the voter that each candidate's statement has been prepared solely by, and contains the representations solely of, that candidate and has not been independently verified by the elections official or any other government official or agency.

**ELECTORAL COLLEGE: INTERSTATE COMPACT**

Ratifies a specified interstate compact that requires the chief election official of each signatory state to appoint the slate of presidential electors that was nominated in association with the presidential ticket that received the largest national popular vote total. Becomes effective if states cumulatively possessing a majority of the total electoral votes have ratified the compact.

**WRITE-IN CANDIDATES**

Requires that in the event of a manual recount conducted under specified circumstances, existing write-in vote processing provisions shall be liberally construed to ensure that each ballot is counted if the intent of the voter can be determined, regardless of whether the voter has complied with the voting instructions.

Requires that vote by mail ballots of special absentee voters, as defined, temporarily living outside of the territorial limits of the United States and the District of Columbia, be postmarked on or before election day and received by their elections officials not later than 10 days after election day. Imposes a state-mandated local program.

**PETITIONS: SIGNATURE GATHERERS**

Requires an initiative, referendum, or recall petition, to reflect in specified language, whether it is being circulated by a paid circulator or by a volunteer. Requires an individual who circulates an initiative, referendum, or recall petition to wear a badge stating, in no smaller than 30-point type, that he or she is either a "paid" signature gatherer or "volunteer" signature gatherer on his or her chest in clear view of all individuals signing or asked to sign the petition. Defines the terms "paid circulator," "paid signature gatherer," "volunteer," and "volunteer signature gatherer".

**PROCESSING WRITE-IN VOTES**

Requires an elections official, in an election that uses a voting system which write-in spaces appear directly below the list of candidates for that office and provide a voting space, after tallying all eligible votes but prior to completion of an official canvass and the issuance of the certified statement of the results, and upon the request of a qualified write-in candidate, including a write-in candidate for an office for which a voter may vote for multiple candidates, to hand tally the votes for a write-in candidate if the elections official makes a specified determination. Requires the official to include the results of a hand tally in the official canvass of the election.

**INITIATIVES: PAID CIRCULATORS**

Requires a firm that engages in the business of paying individuals to circulate petitions and gather signatures for state or local ballot initiatives to register with the Secretary of State and pay a registration fee to be established by the Secretary of State. Requires the Secretary of State to use the fees collected to maintain a directory of these firms on its Internet Web site as well as to defray costs associated with other requirements, as specified. Requires a member of the firm to review the law relating to obtaining petition signatures with each paid petition circulator before the paid petition circulator obtains any signatures for the firm, and to submit to the Secretary of State a statement signed by each petition circulator and the member who conducted the review that the petition circulator has received the review, as well as a copy of the training materials provided to the petition circulator in connection with the review.

Requires a person desiring to vote to produce and show proof of identification, as defined, to the precinct worker at the polling place before being permitted to sign the roster of voters. Provides that if a voter is unable or declines to provide sufficient proof of identification the voter may request and be issued a provisional ballot. Provides exemptions from the requirement to, provide proof of identification for voters residing in state-licensed care facilities that are used as polling places, vote by mail and special absentee voters who cast their ballots by mail and voters who establish a religious objection to being photographed. Provides for purposes of complying with the proof of identification requirement, a registered voter could obtain a state-issued identification card from the Department of Motor Vehicles at no cost. Imposes a state-mandated local program.

Authorizes the governing board of a community college to change election systems. Requires the Board of Governors of the California Community Colleges to approve of the change. Provides that a candidate would be required to reside in, and be registered to vote in, the trustee area. Authorizes the local board to set the initial boundaries for the trustee area. Authorizes the board to determine the number of trustees that the board may be composed of. Authorizes the board to set trustee terms of office.

Requires that for state bond measures that are submitted to the voters for their approval or rejection, the summary of the Legislative Analyst's estimate of the net state and local government fiscal impact to include an explanatory table of the information in the summary, as specified.

Provides that an application for, a vote by mail ballot must be received by the elections official between the 29th and 7th days prior to the election. Authorizes a voter to designate an authorized representative in writing to an elections official to receive, return, or both receive and return, the voter's vote by mail ballot, who is unaffiliated with a candidate, PAC, or political party. **PROTECTION OF VICTIMS AND MURDER WITNESSES: ADDRESS  
CONFIDENTIALITY**

Amends existing provisions that permit any person filing with the county elections official a new affidavit of registration or reregistration to have information relating to his or her residence address, telephone number, and e-mail address appearing on the affidavit, or any list or roster or index prepared therefrom declared confidential upon presentation of certification that the person is a participant in the Address Confidentiality for Victims of Domestic Violence, Sexual Assault, and Stalking program, to include witnesses who testified in a murder trial. Imposes a state-mandated local program.

Requires that the identification envelope for returning a vote by mail ballot include a verification panel, concealed during mailing, setting forth the last four digits of the voter's California driver's license or identification card number or, if unavailable, the last four digits of the voter's social security number and a security flap that would conceal voter's identification information during mailing. Requires that a vote by mail ballot of a member of the Armed Forces of the United States who is stationed outside of the United States be cast by election day and received by elections officials not later than 21 days after election day. **LOS ANGELES COMMUNITY COLEGE DISTRICT: ELECTIONS**

Provides for the establishment of a separate procedure for the election of the trustees of the Los Angeles Community College District. Specifies that a candidate for election must reside in, and be registered to vote in, the trustee area he or she seeks to represent. Provides that the size of the board, nomination of candidates, and term length would be determined, as specified. Requires the governing board of each trustee area to set the boundaries of each trustee area before March 1, 2012, to reflect the population enumerated in the federal 2010 decennial census. If the governing board fails to timely set the boundaries, then the county committee on school district organization shall do so before April 30, 2012. Imposes a state-mandated local program, and makes legislative findings and declarations as to the necessity of a special statute for the Los Angeles Community College District.

Requires that an initiative measure that would increase the vote requirement for any action by the electors or the Legislature, or imposes an extraordinary vote requirement for the amendment of an initiative statute by the Legislature, without approval by the electors by a vote greater than a majority in each house, may itself be approved by the electors only if the measure receives no less than the same percentage of affirmative votes from the electors as the percentage of the vote that would be required for the Legislature to amend the measure's statutory provisions without the electors' approval.
