LOCAL GOVERNMENT: CITIES

Provides that every city with a population of less than 150 people as of January 1, 2010, would be disincorporated as of 91 days after the effective date of this act, into that city's respective county, unless a county board of supervisors determines, by majority vote within the 90-day period following enactment of these provisions, that continuing such a city within that county's boundaries would serve a public purpose if the board of supervisors determines that the city is in an isolated rural location that makes it impractical for the residents of the community to organize in another form of local governance. Requires the local agency formation commission within the county to oversee the terms and conditions of the disincorporation of the city, as specified. Becomes operative only if AB 781 of the 2011-12 Regular Session of the Legislature is enacted.

*AB 65 <u>ELECTIONS: STATEWIDE BALLOT PAMPHLET</u>

GATTO Amends existing law that requires the Legislative Analyst to prepare an impartial analysis of each initiative measure to appear on the ballot. Requires, if a fiscal analysis prepared by the Analyst determines that a measure would provide an increase in revenues to fund new or existing program, that specified language be added to the ballot pamphlet advising that revenue generated will be forever dedicated for said purposes unless the measure is changed by a future measure approved by voters.

Requires the Secretary of State to display on his or her Internet Web site a list of the lobbying interests containing a specific reference to a bill number reported, accompanied by a list of all lobbyist employer's who reported each of those lobbying interests for the prior calendar quarter.

Revises the definition of a new citizen to mean any person who meets all the requirements of an elector of, and who has established residency in, this state, except that he or she will become a U.S. citizen after the 15th day prior to an election.

AB 362 ELECTIONS: SPECIFIED LOCAL OFFICES: WRITE-IN CANDIDATE

LOWENTHAL B 5/9/11 Revises the number of voter signatures required on a write-in petition for the office of superior court judge, to at least 0.1 percent of the registered voters qualified to vote with respect to the office, provided that the petition contains at least 100 signatures but need not contain more than 600 signatures. Requires that, a statement of the write-in candidate meets the statutory and constitutional requirements for that office as specified.

YAMADA Authorizes Yolo County, until December 31, 2017, to conduct elections, other 5/24/11 than statewide primary or general elections or special elections to fill a vacancy in a state office, the Legislature, or Congress, wholly by mail if specified conditions are satisfied. Requires ballot dropoff locations provided shall consist of a locked ballot box located in a secure public building that meets the accessibility requirements for a polling place. Requires if, the county conducts an all-mailed ballot election, to report as specified to the Legislature and to the Secretary of State. Remains effective until January 1, 2018.

AB 435 CANDIDATE'S STATEMENT: NONPARTISAN OFFICE

WAGNER Prohibits the statement of a candidate for a nonpartisan local office from 3/31/11 containing a pledge, promise, or commitment with respect to a matter that could come before the candidate in the office to which he or she is seeking election. Requires that the statement of the candidate's personal background and qualifications be limited to objective, verifiable facts concerning the candidate's experiences, accomplishments, and credentials and not include references to the candidate's beliefs, ideas, ideology, viewpoints, or campaign platform. Requires that each voter's pamphlet contain a notice informing the voter that each candidate's statement has been prepared solely by, and contains the representations solely of, that candidate and has not been independently verified by the elections official or any other government official or agency.

VALADAO 4/5/11 Requires that vote by mail ballots of special absentee voters, as defined, temporarily living outside of the territorial limits of the United States and the District of Columbia, be postmarked on or before election day and received by their elections officials not later than 10 days after election day. AB 481 PETITIONS: SIGNATURE GATHERERS GORDON Requires an initiative, referendum, or recall petition, to reflect in specified 4/5/11 language, whether it is being circulated by a paid circulator or by a volunteer. Requires an individual who circulates an initiative, referendum, or recall petition to wear a badge stating, in no smaller than 30-point type, that he or she is either a "paid" signature gatherer or "volunteer" signature gatherer on his or her chest in clear view of all individuals signing or asked to sign the petition. Defines the terms "paid circulator", "paid signature gatherer", "volunteer", and "volunteer signature gatherer".

AB 503 PROCESSING WRITE-IN VOTES

BLOCK Authorizes an elections official, in an election that uses a voting system which 5/27/11 write-in spaces appear directly below the list of candidates for that office and provide a voting space, after tallying all eligible votes but prior to completion of an official canvass and the issuance of the certified statement of the results, and upon the request of a qualified write-in candidate, including a write-in candidate for an office for which a voter may vote for multiple candidates, to hand tally the votes for a write-in candidate if the elections official makes a specified determination. Requires an elections official who conducts a hand tally, as specified, to include the results of the hand tally in the official canvass of the election.

Provides that a person who is providing care or direct supervision to an elder in a state-licensed or state-subsidized facility or program, and coerces or deceives the elder into voting for or against a candidate or measure contrary to the elder's intent or in the absence of any intent of the elder to cast a vote for or against that candidate or measure is punishable by imprisonment in a county jail or a fine or by both, as specified. HUESO Requires a firm that engages in the business of paying individuals to circulate petitions and gather signatures for state or local ballot initiatives to register with the Secretary of State and pay a registration fee to be established by the Secretary of State, failure to register would be punishable by a fine, as specified. Requires the Secretary of State to, use the fees collected to maintain a directory of these firms on its Internet Web site, as specified. Establishes the requirements for a member of a firm to review the law before the paid petition circulator obtains any signatures for the firm, and submit a statement signed by each petition circulator and member with a copy of the training materials provided to the petition circulator, as specified, to the Secretary of State, failure to submit the required training or verification materials is punishable by a fine, as specified.

*AB 684 COMMUNITY COLLEGE DISTRICTS: TRUSTEE ELECTIONS

BUCHANAN A 8/23/11 e

Authorizes the governing board of a community college district to change election systems, as specified, in accordance with the provisions of this bill and the California Voting Rights Act of 2001, subject to approval by the Board of Governors of the California Community Colleges. Authorizes the governing board of a community college district to establish elections by trustee areas. Authorizes the governing board to determine the number of trustees, and requires the governing board to be composed of 5 to 9 members. Authorizes the governing board to establish, abolish, or adjust trustee areas and terms of office, as specified. Provides for the establishment of a procedure for the number of members, the election of members, and the reapportionment of trustee areas of the Grossmont-Cuyamaca Community College District in accordance with these provisions and the California Voting Rights Act of 2011 (Urgency).

Amends existing provisions that permit any person filing with the county elections official a new affidavit of registration or reregistration to have information relating to his or her residence address, telephone number, and email address appearing on the affidavit, or any list or roster or index prepared therefrom declared confidential upon presentation of certification that the person is a participant in the Address Confidentiality for Victims of Domestic Violence, Sexual Assault, and Stalking program, to include witnesses who testified in a murder trial or has been subpoenaed to testify in a murder trial as specified. Imposes a state-mandated local program.
