### II. MINUTES

Vicki Petersen called the meeting to order at 10:30 a.m.

- Review of the July 14, 2009 minutes.
- ♦ No corrections or changes.
- ♦ Barbara Chambers motioned to approve the minutes. Terri Lipscomb seconded the motion.
- Minutes were approved.

### III. <u>LEGISLATIVE UPDATE</u>

Legislative Representative, Matt Siverling gave a brief outline of legislative updates and deadlines.

- All amendments to bills must take place prior to September 4, 2009.
- There were 65 bills amended prior to the September 4, 2009 deadline.
- None of the 65 bills affect the Clerks Association.
- The last day for the governor to sign or veto a bill is October 11, 2009.
- The Governor threatened to veto any bill that was enrolled, pending resolution of a water bill that pertains to the State budget.
  - O The legislature pulled bills that have been enrolled to avoid any possibility of him vetoing the bills pending the resolution of this water related budget issue. The legislature will resend the bills to the Governor after the budgetary issues with the water bill have been resolved.

<u>AB 772</u> – Local government issues I.D. cards to residents. The ID card is intended to be used by the residents for access to county facilities and services. This is a voluntary program. The decision is county specific. Board of Supervisors who passes an ordinance must approve it.

This bill was discussed at length with San Francisco giving operational and budgetary statistics. Karen agreed to send program statistics to everyone via email.

SB 115 - Requirements for an alternative public employment oath.

- Questions arose on how this can be changed without an amendment to the State Constitution. Matt Siverling agreed to look into the question.
- ➤ Questions arose regarding the oath for Notary Publics. Wardell House agreed to contact Alicia Steward regarding this question.
