Roll Call: Secretary Joe Holland called the roll.

<u>Budget</u>: Treasurer Sue Ranochak said she did not have anything to add to the budget presentation made by Dean Logan at the July 15 Board of Directors meeting. Sue did mention that the audit committee is still working on the audit and that Joe Paul is still leading the audit committee.
