| SUMMARY: | Requires a person who solicits signatures for a proposed initiative measure and does not receive money or other consideration for the specific purpose of soliciting signatures of electors to make certain additional declarations. Relates to determination of the total number of signatures affixed to a petition, signature solicitation requirements, statistical sampling, print requirements, disclosure notices, and fraud. | |

| SUMMARY: | Requires that whenever a local ordinance or measure qualifies for the ballot that proposes to alter, replace, or eliminate the retirement benefit plan of employees of a local government entity, whether by initiative or legislative action, the governing body of the local government entity to secure the services of an independent actuary to provide a statement, or a summary of the statement, not to exceed 500 words in length, of the actuarial impact of the proposed measure upon future annual costs of the retirement benefit plan, and to have this statement printed in the voter information portion of the sample ballot. Requires a specified notice regarding obtaining a copy of the measure to be printed in the voter information portion of the sample ballot, if the text of the measure is not printed on the ballot, nor in the voter information portion of the sample ballot. The requirements of the bill would apply to a city, including a charter city; a county, including a charter county; a city and county, including a charter city and county; a community college district; or a special district. | |

| SUMMARY: | Requires the Attorney General to provide a notice to the proponents stating that, if the proponents intend to circulate the petition for the proposed initiative measure, the proponents shall notify the Attorney General, in the manner prescribed by the Attorney General, of their intention to circulate. Requires, upon receipt of the proponentsqnotice of intention, the Attorney General to prepare a translation of the circulating title and summary of the proposed initiative measure in each language in which the state or a county is required to provide voting materials, as specified. | |
