What is CalPEAC? California has one of the most diverse voter populations carrying with it unique challenges in election administration. Preparing California's election administrators to meet these challenges is the reason the California Association of Clerks and Election Officials (CACEO) created the California Professional Election Administrator Credential Program (CalPEAC). Upon completion of the program's 10 courses, participants will be conferred the CalPEAC Credential and be known as a Registered Election Official (REO). Each course addresses a different component of election administration and is instructed by a professional with experience in the subject area. CalPEAC courses are only open to CACEO members.



#### COURSE SEVEN

REQUIREMENTS FOR PRECINCTS & POLLING PLACES: MANAGEMENT ISSUES/SERVING VOTERS WITH SPECIFIC NEEDS Chris McGinn, North Carolina Central University Assistant Professor, Instructor

This course covers all aspects of precincts and polling places including redistricting, precinct changes, accessibility laws and regulations, and the use of mitigations.

## **COURSE EIGHT**

MANAGING THE ELECTION OFFICE Deborah Seiler, Retired San Diego County ROV, Instructor

This course provides an overview of elections administration and includes budgeting, purchasing, calendaring and staffing and helpful hints and examples.

#### **COURSE NINE**

EMERGENCY PLANNING Jill LaVine, Sacramento County ROV and John Tuteur, Napa County ROV, Instructors. This course centers creating an emergency plan to conduct your election when faced with a multitude of emergencies such as natural disasters, manmade disasters and last minute polling place changes.

### **COURSE TEN**

HOW TO DEVELOP AND IMPLEMENT NEW LEGISLATION Michael Vu. San Diego County ROV, Instructor This course covers legislation from its inception to its implementation. Learn how to market your idea, navigate through the different committees, make amendments, and what it takes to implement the new legislation.
