RE: SB 1346 Elections: Election Day Procedures. Ballot Containers - SUPPORT

Dear Senator Negrete McLeod:

The California Association of Clerks and Election Officials Elections Legislative Committee is pleased to convey **Support** of **SB 1346** (as introduced February 24, 2012). This urgent legislation would allow election officials in larger counties to modify specific Election Day procedures relating to the removal of sealed ballot containers and securing uncounted voted ballots for transport to the central count location prior to the close of polling places in the county.

SB 1346 contains urgency provisions for the conduct of the 2012 Presidential elections in counties greater than 5,000 square miles: San Bernardino, Inyo, Kern, Riverside, Siskiyou, and Fresno counties. More specifically, SB 1346 allows the county election official in those counties to implement procedures that allow a trained ballot security team to remove a sealed ballot container containing voted and untallied ballots and transport the container to a receiving center or central counting location within the county for processing. This bill would prohibit the county election official from tallying the voted ballots or releasing any results prior to the close of polls on Election Day.

SB 1346 will assist county election officials in larger counties, especially at elections with multiple ballot cards and ballot containers with limited capacity, coupled with a high turnout of voters, to accomplish Election Night ballot tabulation and release of results more efficiently to the Secretary of State, media, and the general public.
