NEXT SCHEDULED ELECTIONS:

Primary – June 5, 2018

General – November 6, 2018

STEP 1: REQUIREMENTS FOR A POLLING PLACE

- Area designated for voting is a minimum of 18ft x 20ft.
- At least one electrical outlet available for use.
- The facility is to be available from 6:00am 10:00pm on Election Day.
- The designated voting area is to be free of any activities on Election Day.
- Storage of election equipment delivered a week prior.
- Restroom access on Election Day for the Poll Workers

STEP 2: SURVEY OF THE FACILITY

- A team of surveyors will conduct a site visit to ensure accessibility requirements are met for voters with disabilities.
- o Please note: A survey does not guarantee your facility will be selected for the election.

STEP 3: SELECTION OF FACILITY AS A POLLING PLACE

- o In the event that your facility is selected, you will receive a confirmation letter approximately 3 months prior to the election.
- We would greatly appreciate your facility providing two tables (at least 8 ft) with seven chairs
- The elections office and/or poll workers will contact your facility prior to the election to confirm access on election morning, verify election equipment delivery and room assignment.

VOTER'S CHOICE ACT

NEXT SCHEDULED ELECTIONS:

Primary – June 5, 2018

General – November 6, 2018

Sacramento County is preparing to implement the Voter's Choice Act (Senate Bill 450) to expand voting opportunities for the voters in our community. This Act replaces traditional Election Day polling places with "Vote Centers" where any voter within Sacramento County can vote at any designated location starting 10 days before Election Day. This Act would also increase the number of ballot drop-off locations starting 28 days before Election Day.

Our department is looking to gauge the interest of our existing polling places to serve as Vote Center locations for future elections; would your facility be willing to serve as a Vote Center? For the full eleven days? For four days? Or would your facility prefer to participate as a Vote by Mail Drop-Off Location? Please let our survey team know!
